A RESOLUTION OF THE BOARD OF COMMISSIONERS OF THE SOUTH TRAIL FIRE PROTECTION AND RESCUE SERVICE DISTRICT, LEE COUNTY, FLORIDA, ADOPTING THE TENTATIVE LEVYING OF AD VALOREM TAXES FOR THE SOUTH TRAIL FIRE PROTECTION AND RESCUE SERVICE DISTRICT, LEE COUNTY, FLORIDA FOR FISCAL YEAR 2025/2026; PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the Board of Commissioners of the South Trail Fire Protection and Rescue Service District, Lee County, Florida, on September 3, 2025 adopted Fiscal Year 2025/2026 Proposed Tentative Millage following a public hearing as required by Florida Statute 200.065; and

WHEREAS, the Board of Commissioners of the South Trail Fire Protection and Rescue Service District, Lee County, Florida, held a public hearing as required by Florida Statute 200.065; and

WHEREAS, the gross taxable value for operating purposes not exempt from taxation within the South Trail Fire Protection and Rescue Service District has been certified by the County Property Appraiser to the Board of Fire Commissioners as \$10,208,677,604.

NOW THEREFORE, BE IT RESOLVED by the Board of Commissioners of the South Trail Fire Protection and Rescue Service District, Lee County, Florida, that:

1. The Fiscal Year 2025/2026 tentatively adopted operating millage rate is 2.5000 mills which is greater than the rolled-back rate of 2.3959 by 4.346%.
2. This resolution shall take effect immediately upon its adoption.
